AI in Med ED

Read: Understanding Al Vital Signs

Fatema Shipchandler, PGY3 at Swedish First Hill, and her sisters Ruqaiya and Zainab developed Al Vital Signs: What Every Clinician Needs to Know, a resource introducing a framework to evaluate Al tools in medicine and applying it to ProvidenceChat, an Al tool approved for use in their hospital system.

Read: Live Translation is Actually Here - What That Means in Clinic and Teaching

Google Translate's new Live Translation feature now enables real-time, back-and-forth conversations with transcripts and language-learning tools. While not a replacement for certified interpreters in complex discussions, it may help reduce friction in everyday clinical interactions like greetings, scheduling, and discharge reminders—and even offers opportunities for training exercises around translation-friendly communication.

Read: Generative AI in Medicine: NEJM Letters Meet the AMA's "Don't Rush"

Recent pieces from NEJM and the AMA urge caution in adopting generative AI in medicine, emphasizing governance, rigorous evaluation, and safeguards over hype. As AI shifts from novelty to infrastructure, leaders are encouraged to integrate AI literacy into training, set clear use-cases with stop-rules, and prioritize protections for vulnerable users—governance before hype, humans before chatbots.
